## REGULATIONS AND CONDITIONS OF PLAY SYLVIA DYNE TOURNAMENT

**AMENDMENT TO THE CONDITIONS OF PLAY - NO. 2: Reserves  
- NO. 11: Scoring**

*The new rules introduced By Bowls South Africa [applicable from 1 November 2010], will be incorporated into the Conditions of Play at the beginning of this tournament.*

These championships shall be conducted under the Laws of the Sport of Bowls, South African edition, and shall be subject to the following local regulations and conditions of play:

1. All competitors shall be bona fide members of Clubs affiliated to the JBA.
2. Each team of 3 (plus 2 x reserves) entered in the tournament shall consist of bona fide members of the same Club. All reserves may not be entered in a championship, if they are a member of another team in the same championship.
3. The match shall consist of 18 ends. If the scores are equal after 18 ends have been played the match shall be drawn with each team getting 1 point. In the case of inclement weather a minimum of 15 ends will constitute a game.
4. The tournament shall be played on a round robin basis.
5. The winner of each section shall be determined by the highest number of points obtained throughout the round-robin phase. Thereafter, should two or more teams in the same section be equal on points, the winner shall be determined by that side with the highest shot aggregate over the round-robin phase.
6. Trial ends **ARE** permitted.
7. Play shall commence at 13h30 (unless otherwise instructed by the Controlling Body) but ten minutes grace shall be allowed. Players who arrive after the expiry of the ten minutes grace will be scratched except that the Umpire appointed may exercise his/her discretion when players are prevented from arriving at a green on time through circumstances beyond their control while in transit to the venue of play. The Umpire's decision shall be final.
8. Players must report at the time scheduled to play unless they have a Bye.
9. In the event of inclement weather the onus shall be on the Skip to contact their section Captain:

10. It is the responsibility of each Skip to ensure that she plays the correct opponent in each round. All results, as they are received by the Secretary, will be accepted as final and binding.

11. **SCORING**

One scorecard will be furnished for each game on which the names and initials of all players must be entered in capital letters.

It has become the responsibility of the Skip in the team to keep the score card supplied by the Controlling Body of the event.

The scoreboard must be similarly completed by a player in the opposing team.

12. **TEAMS**

The official declaration form recording the personnel of a trips team plus 2 reserves must be completed by the Skip of the team prior to the commencement of the first match in the tournament. Five players may be registered.

14. **DRESS**

In addition to the regulations framed under the Laws of the Sport of Bowls, the blouses worn by players must have conventional collars. It must be borne in mind that once Clubs have had their colours approved, the wearing of these colours is only permissible if every member of a team wears them (i.e. the complete team) otherwise the standard white or cream clothing rule must apply.

15. **GREENS**

a) For all Championships the outside boundary of an end rink shall not be less than 0,5m from the side ditch.

b) Except with the permission of the Controlling Body players shall not be moved from one green to another on any one day.

16. **TEAS**

Clubs are required to provide teas, at ruling Club prices, for Competitors.

17. **PLAY OFFS** – Section Winners 1 plays 3  
2 plays 4

Winners of each of the above will play for the Final.
